1.2. Recommended Use and Restrictions on Use

This product is intended for use only by adults 21 or older. For lawful use only. This product is concentrated and should not be used undiluted. Not for use with tobacco or nicotine. Avoid contact with the skin, eyes, wood surfaces, and fabrics. Keep out of reach of children and pets. Consumers should determine and conduct their own safety standards and testing. The United States Food and Drug Administration, Center for Disease Control and Prevention, and multiple state governments are investigating numerous instances of severe respiratory illnesses and deaths associated with the use of vaping products. Symptoms include breathing difficulty, shortness of breath, chest pain, mild to moderate gastrointestinal illness, fever, or fatigue. To date, True Terpenes has not received any evidence confirming that this product has caused any adverse health consequences. However, the State of Oregon has taken steps to investigate the use of certain additives in vape pens which have been associated with these illnesses, including, among other chemicals, Squalane, Squalene and MCT oil. SECTION 4: First-Aid Measures

4.1. General First Aid Information

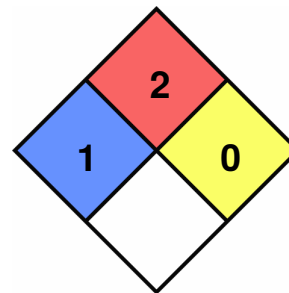
